Tom Segalla was honored with the 2017 DRI Louis B. Potter Lifetime Professional Service Award during the DRI Annual Meeting last October. Here, Tom shares some reflections on his professional life and development, including what DRI has meant to him during his 37 years of membership.

Receiving a "Lifetime Award" can have different meaning to

different people. To me, it is recognition that there is still a lot more to be accomplished.

Early in my legal career, I developed a motto that has pervaded the development of my career, my ability to develop loyal clients, make friends, and encourage colleagues; and which facilitated my desire to become the best professional possible—not just a lawyer. My goal was to make a difference. My motto became: "Creativity – Visibility – Persistence."

In the late 1970s and early 1980s, while I believed that I had the "creativity" to achieve my goal, I recognized that I needed a platform to achieve that goal. In marched DRI, which provided the "visibility" to achieve my professional goal realistically. The following quote epitomized both my initial and continued involvement in DRI:

I recognized that being a realist was important to my professional growth.
